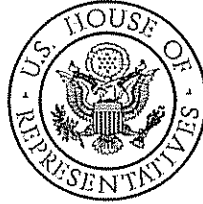

Dear Attorney General Holder:

I am writing regarding a matter of grave concern to me and the over 11,000 citizens of my congressional district in the Village of Crestwood. On April 18, 2009, I first learned through media reports that Crestwood residents have been exposed to drinking water contaminated with perchloroethylene (PCE), a chemical linked to cancer, liver damage and neurological problems. The source of the water is a well operated by the Village of Crestwood. As a result of the recent publicity, the Illinois Environmental Protection Agency (IEPA) and the Illinois Attorney General have initiated investigations.

On April 20, 2009, I transmitted a letter to United States Environmental Protection Agency (USEPA) Administrator Lisa Jackson setting forth my outrage that over the past 20 years, more than 51 million gallons of poisonous water per year has been distributed to Crestwood residents. I further requested from the USEPA a full report on the status of enforcement procedures and obligations in this instance under the Safe Drinking Water Act, whereby municipalities are required to verify the safety of local drinking water under Section 114 of P.L 104-182, and a meeting with USEPA officials has been tentatively scheduled for this week.

On Saturday, April 25, 2009, I spoke to several hundred concerned Crestwood residents at a meeting organized by the citizen whose diligence exposed the situation in that community after her son suffered leukemia and her daughter developed a brain tumor while there. I informed these citizens that I would not only pursue investigation and redress through the USEPA, but also, seek the assistance of the U.S. Department of Justice (DOJ) to ensure that the responsible parties in this case are indeed held accountable. Therefore, I am specifically requesting that the DOJ conduct a formal, full-fledged investigation in order to determine any civil or criminal

violations on the part of the Village of Crestwood, or other parties which may have knowingly supplied residents with contaminated water after informing them that the water supply was safe.

I am also requesting participation by DOJ officials, along with USEPA officials, in a town hall meeting about the Crestwood water issue that I will conduct in the 1st Congressional District on Saturday, May 9, 2009.
